AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT
BY AND BETWEEN THE VILLAGE OF KELLEYS ISLAND, OHIO (THE VILLAGE)
AND COSGROVE JONHENRY LLC FOR PUBLIC POLICY AND LEGISLATIVE
SERVICES NECESSARY TO OBTAIN FUNDING FOR VARIOUS PROJECTS ON
KELLEYS ISLAND AND DECLARING AN EMERGENCY

WHEREAS, the Village of Kelleys Island, Ohio needs to have an advocate in pursuing both State and Federal funding for various projects on Kelleys Island; and

WHEREAS, the parties agree to enter into a contract wherein Cosgrove Jonhenry LLC agrees to provide public policy and legislative services necessary to obtain funding for various projects on Kelleys Island.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF KELLEYS ISLAND, COUNTY OF ERIE AND STATE OF OHIO AS FOLLOWS:

SECTION 1. That the Council of the Village of Kelleys Island, Ohio does hereby authorize the Mayor to enter into a contract by and between the Village of Kelleys Island, Ohio and Cosgrove Jonhenry LLC for public policy and legislative services, said contractual letter with standard terms attached hereto and incorporated herein as if fully rewritten as Exhibit "A"

SECTION 2. That the funds needed for this transaction are hereby appropriated or will be appropriated.

SECTION 3. That the contract be approved by the Village Solicitor.

SECTION 4. That Ordinance No. 2021-O-30 is hereby repealed.

SECTION 5. That it is found and determined that all formal actions of the Council of the Village of Kelleys Island concerning and relating to the adoption of this Ordinance were adopted in an open meeting of such body, and that all deliberations of the Council of the Village of Kelleys Island and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 6. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and welfare of the inhabitants of the Village of Valley View, and for the further reason that the need for funding projects on the Island is of immediate concern for the health, safety and welfare of the citizens of Kelleys Island, therefore, this Ordinance shall be in effect from and after the earliest period allowed by law.
