Before the Island became a Village, it was a township.

**CONSTABLES** - One Constable was appointed in 1840: Joseph Willett, Theodore W. Morgan, Lucius Dean, Charles M. Verguson, Charles Carpenter, John Dean and John Estes.

This increased to two constables in 1850 and included: William Kelley, Jared Titus, Eldriedge Preston, Orson A. Chaffee, George Osborn, Oscar Dean, Milo Clemons. George C. Huntington, Jonathan S. Harris, George P. Bristol, John Stokes, John F. Martin, Charles Mitchell, Jared Dwelle., Michael Hughes, Henry Dishinger, Frederick Dishinger, Henry Elfers, Henry Trieschman, J. Difenbach, A. Zehringer.

**MARSHALS** - Here is a somewhat complete list of the Marshals from 1887 to 1895 Wm. H. Harvey, Charles Seeholzer, Charles Martinb, W. S. Hamilton, Henry Elfers and William E. Mootz.

When the Island became a Village in 1887, it was allowed to pass its own legislation. Here are some of the more interesting entries in the minutes.

**July 3, 1890** - Mr. McGurn offered the following. Be it resolved that the Committee on Police be authorized to purchase badges for Marshall and Deputies and the same to be worn in a conspicuous position on person of said officer or officers. Seconded and carried.

Later: The Mayor reported that the Marshal's badges were wrongly lettered. Mayor instructed to write to the manufacturers.

**September 3, 1890** - The Committee on Police recommend the appointment of two Deputy Marshals immediately and would suggest the appointment of Hy. Elfers and Phillip Rosworm. [H. E. Dwelle and Phillip Rosswurm were actually appointed.]

August 21, 1890 - Ordinance 21 - Authorizing the appointment of a reserve watch or policemen.

Section I - Be it ordained by the Incorporated Village of Kelleys Island that the Mayor is hereby authorized, when in his judgement it is necessary, to appoint a reserve watch of not more than 10 persons who may be called into active service b said Mayor or whenever he may deem the same necessary for the preservation of good order in said Village in case of emergency.

Section II – Said Mayor in case of his calling said reserve force into actual service, shall report the same to the Council at its next meeting, together with his reasons therefore and the length of time each has served.

Section III – When said reserve force is so called into actual service, the members thereof shall be under the control and direction of the Marshal of said village, and they shall not be entitled to receive any compensation except when in actual service, for which they shall receive the sum of \$2.00 per in full compensation for such services. Passed August 21, 1890

May 19, 1892 - Report of Committee on Police & Public Health: The committee recommend the employing of a special police to go on duty at 7 pm and remain on duty until 12 pm each night during the summer and part of the fall or as long as required. We recommend also that an ordinance be passed closing all saloons in the corporation at 11 pm.

We recommend that the Deputy Marshal be authorized to purchase a police outfit of nipples, hand-cuffs, club, whistle and dark lantern. Also the purchase of a guide for Constables and Police.

The Deputy Marshall reports that the Station House is not properly supplied with the convenients for caring for prisoners; such as slop pail, wash basin, looking glass and towels, and that the windows be opened.

In 1900 references to the Island's Marshals disappeared and the term Police Officer begin to appear. It is not clear when the first official Police chief was appointed.
