AN ORDINANCE ACCEPTING A BID FOR THE HUNTINGTON STREET WATERLINE REPLACEMENT PROJECT AND DECLARING AN EMERGENCY.

WHEREAS, the Village of Kelleys Island is accepting bids for the Huntington Waterline Replacement Project; and

WHEREAS, specifications for the said project were placed in the Sandusky Register on March 2, 2023, and March 9, 2023; and

WHEREAS, sealed bids were received at the offices of Bramhall Engineering and Surveying Co., 801 Moore Road, Avon, Ohio 44011 on March 23, 2023; and

WHEREAS, the bid of D2 Excavating, LLC for the sum of \$569,800.51 was determined by Council to be the lowest and best bid submitted.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF KELLEYS ISLAND, COUNTY OF ERIE AND STATE OF OHIO AS FOLLOWS:

SECTION 1. That the bid of D2 Excavating, LLC for the Huntington Street Waterline Replacement Project is hereby determined to be the lowest and best bid received and the same is hereby accepted.

SECTION 2. That the Mayor be and he is hereby directed to enter into a contract with D2 Excavating, LLC as set forth in the bid specifications.

SECTION 3. That the contract be approved by the Solicitor.

SECTION 4. That the funds needed for this transaction are hereby appropriated or will be appropriated.

SECTION 5. That it is found and determined that all formal actions of the Council of the Village of Kelleys Island concerning and relating to the adoption of this Ordinance were adopted in an open meeting of such body, and that all deliberations of the Council of the Village and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 6. That this Ordinance shall be adopted as an emergency measure to take effect immediately upon its adoption and authorization by the Mayor an Clerk, respectively, and for the further reason that it is necessary to submit loan papers immediately to secure funding by May 2023 to commence project by June 2023, for the preservation of the public health, safety and welfare of the citizens of Kelleys Island, Ohio, this Ordinance shall be in full force and effect immediately upon its passage.
