ORDINANCE NO. 2023 – O - 04

INTRODUCED BY: COUNCILMAN SCOT SMITH

AN ORDINANCE REQUIRING REIMBURSEMENT OF CERTAIN COSTS TO THE VILLAGE OF KELLEYS ISLAND, OHIO AND DECLARING AN EMERGENCY.

WHEREAS, The Safety Committee has recommended that any employee or persons engaged in service for the Village of Kelleys Island, Ohio, whether it be as an employee or volunteer be required to reimburse the Village for all monies expended for training, compensatory time received and any tuition costs if they leave the service of the Village for any reason within ~~two~~ one year from the time the monies are expended. **Said reimbursement may be waived at the discretion of the Mayor.**

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF KELLEYS ISLAND, COUNTY OF ERIE AND STATE OF OHIO AS FOLLOWS:


SECTION 1. That any employee or any person who is engaged in service for the Village of Kelleys Island, Ohio, whether it be as an employee or volunteer be required to recompense the Village for all monies expended for training, compensatory time and any tuition costs, if they leave the Village or are terminated for any reason within **one** year of from the time the monies are expended. **Said reimbursement may be waived at the discretion of the Mayor.**

SECTION 2. The department heads are hereby directed to have all personnel under their control execute an agreement as set forth in Exhibit “A” attached hereto and incorporated herein.

SECTION 3. That it is found and determined that all formal actions of the Council of Kelleys Island concerning and relating to the adoption of this Ordinance were adopted in an open meeting of such body, and that all deliberations of the Council of the Village of Kelleys Island and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 4. That this Ordinance shall be adopted as an emergency measure to take effect immediately upon its adoption and due authentication by the Mayor and the Clerk, respectively, and for the further reason that is necessary to have this policy in place for 2023 and for the preservation of the public health, safety and welfare of the citizens of Kelleys Island, Ohio, this Ordinance shall be in full force and effect immediately upon its passage.
