ORDINANCE NO. 2023 – O - 06

AN ORDINANCE AMENDING & 32.09 (E) ENTITLED “MEETINGS”
OF THE KELLEYS ISLAND CODIFIED ORDINANCES.

WHEREAS, the purpose of this amendment is to change the regular session meeting days and or times for the Village Council meetings.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF KELLEYS ISLAND, COUNTY OF ERIE AND STATE OF OHIO AS FOLLOWS:

SECTION 1:

That & 32.09 (E) which states as follows: (E) The Village Council shall meet in regular session during the months of May, June, July, August and September, on the second Thursday of each of the aforesaid months at 7:00 p.m., in the Town Hall, Division Street, Kelleys Island, Ohio. Further, the Village Council shall meet in regular session during the months of October, November, December, January, February, March, and April on the second Saturday of each of the aforesaid months at 10:00 A.M., in the Town Hall, Division Street, Kelleys Island, Ohio. Should any holiday fall upon the date for a regular meeting or in the event it is necessary to reschedule a regular session of Council due to the unavailability of any of its members, the Village Council shall reschedule such regular meeting to another date within the same month in lieu thereof.


Is hereby amended to:

(E) The Village Council shall meet in regular session during the months of March through December, on the second Saturday of each of the aforesaid months at 10:00 A. M., in the Town Hall, Division Street, Kelleys Island, Ohio. Should any holiday fall upon the date for a regular meeting or in the event it is necessary to reschedule a regular session of Council due to the unavailability of any of its members, the Village Council shall reschedule such regular meeting to another date within the same month in lieu thereof. The Village Council shall be in recess during the months of January and February, subject to the call of a special meeting pursuant to the procedure set forth in & 32.09 (F) of the Kelleys Island Codified Ordinances.

SECTION 2. That it is found and determined that all formal actions of the Council of Kelleys Island concerning and relating to the adoption of this Ordinance were adopted in an open meeting of such body, and that all deliberations of the Council of the Village of Kelleys Island and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 3. That this Ordinance shall be in effect from and after the earliest period allowed by law.
