**RESOLUTION NO. 2023 – R - 02**

**A RESOLUTION APPOINTING AN ASSESSMENT EQUALIZATION BOARD  
PURSUANT TO &727.16 OF THE OHIO REVISED CODE AND DECLARING  
AN EMERGENCY.**

WHEREAS, due to objections to the Lake Court assessment it is necessary to appoint an assessment equalization board.

**NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF KELLEYS ISLAND, COUNTY OF ERIE AND STATE OF OHIO, AS FOLLOWS:**

**SECTION 1.** Jack Hostal, Kurt Krause and Richard Schwartz, three disinterested freeholders of the Village of Kelleys Island, Ohio are appointed as an assessment equalization board to hear and determine all written objections filed in accordance with law to the estimated assessments filed with the Clerk of this Council pursuant to Resolution No. 2023 – R - 02


**SECTION 2:** The assessment equalization board shall meet at 11:30 AM, April 8, 2023 at the Village Hall, for purposes aforesaid, and on completion of the hearing and any adjournments, shall report its recommendations, including any changes which should be made in the estimated assessment, to this Council.

**SECTION 3:** The Clerk of Council has notified each person who has filed a timely written objection to the estimated assessment of the time and place of the hearing and the assessment equalization board.

**SECTION 4:** That it is found and determined that all formal actions of the Council of Kelleys Island concerning and relating to the adoption of this Ordinance were adopted in an open meeting of such body, and that all deliberations of the Council of the Village of Kelleys Island and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

**SECTION 5:** That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and welfare of the inhabitants of the Village of Kelleys Island, and for the further reason that the petitioners have been notified and are participating in the hearing set for April 8 , 2023, therefore, this Resolution shall take effect immediately upon its passage.
