ORDINANCE NO. 2022 – O - 15

AN ORDINANCE AUTHORIZING THE CLERK-TREASURER TO TRANSFER \$ 9179.03 FROM THE ROAD CONSTRUCTION LEVY FUND 2905 TO THE SWEETBRIAR ASSESSMENT FUND 3301 AND AUTHORIZING ANY FUTURE PAYMENTS TO THE SWEETBRIAR ASSESSMENT FUND TO BE TRANSFERRED FROM THE ROAD CONSTRUCTION LEVY FUND AND DECLARING AN EMERGENCY

WHEREAS, the Village of Kelleys Island, Ohio is responsible for paying its share of the 2013 Sweetbriar Assessment Project; and

WHEREAS, the Clerk/Treasurer also needs to be able to fund any future payments to the Sweetbriar Assessment Fund from the Road Construction Levy Fund, and is requesting authorization to do so.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF KELLEYS ISLAND, COUNTY OF ERIE AND STATE OF OHIO AS FOLLOWS:

SECTION 1. That the Council of the Village of Kelleys Island, Ohio does hereby authorize the Clerk /Treasurer to transfer \$ 9179.03 from the Road Construction Levy Fund to the Sweetbriar Assessment Fund and further authorizes the Clerk/Treasurer to make any future payments required by the Sweetbriar Assessment to be transferred from the Road Construction Levy Fund to the Sweetbriar Assessment Fund

SECTION 2. That the funds needed for this transaction are hereby appropriated or will be appropriated.

SECTION 3. That it is found and determined that all formal actions of the Council of the Village of Kelleys Island concerning and relating to the adoption of this Ordinance were adopted in an open meeting of such body, and that all deliberations of the Council of the Village of Kelleys Island and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 4. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and welfare of the inhabitants of the Village of Kelleys Island, and for the further reason that the Village portion of the Sweetbriar Assessment is due, therefore, this Ordinance shall be in effect from and after the earliest period allowed by law.
