They are going to be reaching out to the person we put in charge for the short term rental administrator position. Joe and I are working on a few more minor details but, should be ready to go live any day.

A.M. Eaton: Is this a full liquor license?

Mayor Ehrbar: We have Bill Gallagher with us.

Bill Gallagher: The application is self-explanatory from the standpoint of Liquor Control. Bought Brew Pub from Patti Johnson and we have a pretty good plan to get all this up and running. We have already started on some improvements making it look more acceptable and not like a closed down restaurant. Revenues are in application. This is an application that I want to transfer into Kelleys Island so we can operate the business as a tavern / restaurant. With your approval we will be able to go ahead and make application to the State. You guys will have another chance to review before submission.

J. Wolfe: Is this the transferring of the license which is a brew license?

Bill Gallagher: No, it is bringing a new liquor license.

J. Wolfe: So, there is no brewery then?

Bill Gallagher: When the former owners closed, they let the license lapse so, we had to apply for a new license.

Motion to approve TREX application made by J. Wolfe; second by A.M. Eaton. All in Favor. Motion Passed.

In 2017-2018 the FAA awarded the Village of Kelleys Island \$82,000 for the property that is located between Haig property and Airport parking lot. FAA is now stating that this was a mistake and wants their money back. Working with RS&H they worked out several different things that we will need money for at the Airport. They have got the total that we will need to pay back down to \$16,000. I am asking for a motion to sign a check for \$16,000 and get this off the table. Property remains ours.

Brandon Davis: We have had similar success with transient short-term rentals progress process in NC. Our firm was actually asked to be a part of the Short-Term Rental process. One of the things that the county did was to bring the public together to be able to have voices heard and passed legislation that is inclusive to their input.

It was a process that went from Planning Board to Council to County Commissioner. These meeting are continuing to happen and the legislation looks pretty awesome.

One of the things we have been asking for on Kelleys Island is for the same thing. We've made some opportunities to be heard and we requested a public forum which has not been granted. What we would ask is for an informational meeting of some sort where the public gets an opportunity to be heard and we hear some things that have happened behind the scenes. The legislation we all think is necessary and we have asked for some of that by email and through phone calls. There has been no response. So, if we could get some response.

Roz Ahner: I vote here. I raised my kids here. I raised my grandchildren here. Some of the people who come up here to speak have commented that they speak for the residents of Kelleys Island. They do not. I speak for myself. I agree with what you are doing. I know it's been open and above board.
